5) Completion of 2018 Primary Election Canvass and Declaration of Results. *Presenter:* Peggy Carabajal; Sponsor: County Manager for Regular County Business

County Clerk Peggy Carabajal gave a report on the 2018 Primary Election. She thanked the Commission for the use of the commission room for an early voting site. Also, thank you to county staff, IT Department, Finance Department, Detention, Manager's Office, Maintenance, MS. Poll Officials, just everyone that helps with the preparation of Election Day. She thanked her staff, they work tirelessly through the election process with long days and even working on Saturdays.

There were a few changes from Election night, we inserted the UOCAVA voters, (Uniformed and Overseas Citizens Absentee Voting Act). We have to report by precinct and break it down with the three major parties, Democrat, Republican and Libertarian.

Eligible voters were 32,769. There are 18,458 Democrats, 14, 066 Republicans and 245 Libertarians.

There was a total of 8, 594 that voted in the 2018 Primary Election.

Absentee - 521 Democrats, 290 Republicans, 1 Libertarian - Total Absentee 812

Early - 1,395 Democrats, 897, Republicans, 4 Libertarians - Total Early 2, 296

Election Day - 3,159 Democrats, 2,286 Republicans, 8 Libertarians - Total 5,453

Hand Tallies - 17 Democrats, 15 Republicans, 0 Libertarian - Total 32

Provisional - 1 Democrat, 0 Republican, 0 Libertarian - Total 1

Total number of voters that voted 8,594.

We are here before this Commission to finalize the 2018 Primary Canvass; this Commission is the Canvassing Board so we are at the discretion of the Board as to how to proceed. We can go over each results tape, early voting tapes, absentee tapes, voting convenience tapes. Ms. Carabajal said that we have checked and rechecked everything.

Also, the Secretary of State will canvass the 33 counties by June 26, 2018 and then on June 27th we will have an automatic recount for Public Regulation Commission District 5 since the unofficial margin of victory was less than 1%.

Recommendation is for approval unless the Commission has any questions.
