- 1) The meeting was called to order by Chairman Aragon at 5:01 P.M.
- 2) Mr. Montoya led the Pledge of Allegiance.

## PUBLIC COMMENT:

Mr. Monette read public comment submitted by Duana Draszkiewicz. Ms. Draszkiewicz stated that businesses are not calculating the correct GRT for the unincorporated part of the county, and the county is not receiving their fair share of the GRT.

Commissioner Mraz stated that in order for a particular area to have its own zip code there needs to be at least 20,000 mail drop off points.

Mr. Monette announced that the NACO virtual convention is starting this week for the commissioners to tune in.

Chief Culp reported that the state sent the county 70,000 cloth masks to be given to the municipalities, county departments as well as the Belen, Los Lunas and SODA schools and private and nonprofit organizations. the general public can request masks if needed. There are no additional N-95 masks available from the state but the county has enough to last up to 6 months.

Commissioner Saiz stated that he had spoken to Chief Gabaldon from the Village of Los Lunas and he is pleased with how the county and village are working together during this time.

Commissioner Hyder reported that the OAP Advisory Council has a meeting tomorrow, they are moving along and working on the bylaws also NMDOT is holding a public hearing in August regarding the Jarales overpass.

  Ms. Gonzales stated that the proposed contract would allow the county to employ 3 part time, senior aged individuals. The contract award amount is \$28,779.00. (See Exhibit H)
- 11) Consideration to approve North Central New Mexico Economic Development District Non-Metro Area on Aging Title III Federal and State Sub-Award Contract No. 2020-21-60028. Presenter: Community Development Director, Nancy Gonzales, Sponsor: County Manager for Regular County Business

Ms. Gonzales stated that the award amount is \$489,943.18. The county will now be on an expense-based reimbursement this year in place of the previous unit-based reimbursement. (See Exhibit I)

12) Consideration to approve North Central New Mexico Economic Development District Non-Metro Area on Aging Nutrition Service Incentive Program (NSIP) Subrecipient Contractor Sub-Award – Contract No. 60028. Presenter: Community Development Director, Nancy Gonzales; Sponsor: County Manager for Regular County Business Ms. Gonzales stated that the contract in the amount of \$92,027.80 would allow for the purchase of raw foods for the OAP. (See Exhibit J)

13) Approval of the Managed Services Professional Agreement between Valencia County and Advanced Network Management (ANM), Inc. Presenter: Information Technology Director, Tesa Mast; Sponsor: County Manager for Regular County Business

Mr. Porter stated that this program would be 24/7 continuous security monitoring of the county's I.T. network, an IT position has been eliminated to fund this. Mr. Nance stated that this is a state contract with set terms and prices, the county has not yet received the final documents. Mr. Nance requested that the county manager be given the authority to sign the contact once it is received. Ms. Mast stated that I.T. has been using ANM INC. for the past 6 months on a month to month basis and they have abided by all the terms and conditions.

Commissioner Saiz moved for approval to delegate authority to the county manager as long as the state contract is abided by. Seconded by Commissioner Mraz. Roll call vote. County Assessor Dominguez-Romero stated that the report is the last piece of her evaluation that needs to be sent to the Property Tax division. Certification of value for the 2020 mill levy will be submitted on the 24th of this month, there is the possibility of a 2.82% increase in value which could possibly generate an additional \$380,000.00

The bonds are scheduled to be sold in September and the county should receive funds February 2021.
