# Juvenile Justice FY2021 Update. Presenter: Grants Manager Jeremias Silva

Mr. Silva introduced Father Robert Mundy who is the chairman of the Juvenile Justice Board. Father Mundy, Continuum Coordinator Cassandra Montano and Noelle Chavez spoke on the functions of the board and the programs that are offered for youth in the community. Heather Benavidez introduced herself as the newest member of the Juvenile Justice Board. Commissioner Hyder stated that the current Juvenile Justice board is a great group, kudos to them.

Commissioner Aragon reported that NACO is really going in depth on the American Rescue Plan grant and how that money can be used, they are hosting a workshop on the topic. Mr. Silva stated that everyone is waiting for guidance from the Department of Treasury on how the grant money can be utilized, he will bring a project list to the commission for approval once it is complete.

### PRESENTATION:

6) FY 2020 Audit. Presenter: Kubiak, Melton & Associates, LLC Daniel Trujillo Ms. Trujillo introduced Daniel Trujillo who is a CPA with Kubiak Melton & Associates.

Mr. Trujillo stated that he is an audit partner with Kubiak Melton & Associates, this is the company's first year doing the county's audit. The completed audit is published and available on the state auditor's website. He stated that there were no difficulties performing the audit and it was submitted on time. Mr. Trujillo went over the FY 2020 audit findings, the repeat findings as well as the non-compliant findings. The county received an unmodified opinion for the FY 2020 audit. Mr. Trujillo stated that its their goal to be with the county for 8 years, they are available to help the county implement processes to make improvements. (See Exhibit A)

7) Approval of Resolution 2021-\_\_: FY2020 Financial Audit. Presenter: Finance Director, Loretta Trujillo; Sponsor: County Manager for Regular County Business

Ms. Trujillo stated that DFA Local Government Division requires a resolution showing commission acceptance and approval of the audit.

8) Approval of MOA Between Valencia County and City of Belen for the Purpose of Grading City of Belen Dirt Roads. Presenter: Public Works Director, Lina Benavidez, Sponsor: Commissioner Joseph Bizzell

Ms. Benavidez requested approval of a MOA between the county and the City of Belen for grading 2 miles of roadway, the city does not have the equipment needed to grade the roadway. The county will be charging the city for time and equipment used.

9) Approval of Resolution 2021-\_\_\_: Adopting the Road Project Priorities for Expending County General Obligation Bond Funds. Presenter: Public Works Director Lina Benavidez, Sponsor: Chairman Gerard Saiz

Ms. Benavidez presented and asked for approval of the resolution for expending GO bond funds on road projects and equipment.

Commissioner Hyder moved for approval. Seconded by Commissioner Aragon. Roll call vote. Commissioner Richardson voted yes. Commissioner Bizzell voted yes. Commissioner Hyder voted yes. Commissioner Aragon voted yes. Chairman Saiz voted yes. Motion carried 5-0.

County Clerk Milam announced Resolution 2021-20. (See Exhibit D)

10) Approval of MOA Between Valencia County and the Village of Los Lunas for Reimbursement of Legislative Funds for the I-25 Corridor Design and Construction. Presenter: Grants Manager Jeremias Silva, Sponsor: Chairman Gerard Saiz

Mr. Silva stated that there was an error on how this item was listed on the agenda, it was mistakenly listed as legislative funds when it is actually GO bond funds. Mr. Pato stated that he is concerned about the mislisting on the agenda, he suggested that this item be tabled and put on the agenda for the next meeting.

Commissioner Hyder moved to table this item. Seconded by Commissioner Bizzell. Roll call vote. Commissioner Richardson voted yes. Commissioner Bizzell voted yes. Commissioner Hyder voted yes. Commissioner Aragon voted yes. Chairman Saiz voted yes. Motion carried 5-0.

11) Consideration to Approve a Contract with Kulik Strategic Advisers Inc. DBA KSA for the Market Assessment and Clinical Services Needs Study. Presenter: Purchasing Agent Rustin Porter, Sponsor: County Manager for Regular County Business

Mr. Porter stated that he is seeking approval of a contract with Kulik Strategic Advisors for the amount of \$169,176.71. Chairman Saiz asked what is the timeframe for the study to

be complete. Mr. Porter stated that the study can take 90-180 days. Commissioner Saiz asked if a 60-day turnaround time can be pushed for. Mr. Pato stated we want to make sure the study is comprehensive but it can be made clear that time is of the essence. Commissioner Aragon stated that UNM may have some information that might be helpful to speed the process along.

Commissioner Aragon moved for approval. Seconded by Commissioner Hyder. Roll call vote. Commissioner Richardson voted yes. Commissioner Bizzell voted yes. Commissioner Hyder voted yes. Commissioner Aragon voted yes. Chairman Saiz voted yes. Motion carried 5-0. (See Exhibit E)
