County Clerk Milam thanked the poll officials, presiding judges, Los Lunas schools, Sarah Kerr at Meadowlake Community Center and the BOE staff for doing an outstanding job. BOE Administrator Candace Teague stated that she is requesting commission approval of the canvass for the Congressional District 1 Special Election which was held to fill the vacancy left by Deb Haaland. There was a total of 5,285 registered voters in Congressional District 1, only 931 people voted which is a little over 17% voter turnout.

Commissioner Bizzell moved for approval. Seconded by Commissioner Richardson. Roll call vote. Commissioner Bizzell voted yes. Commissioner Richardson voted yes. Chairman Saiz voted yes. Motion carried 3-0. (See Exhibit A)



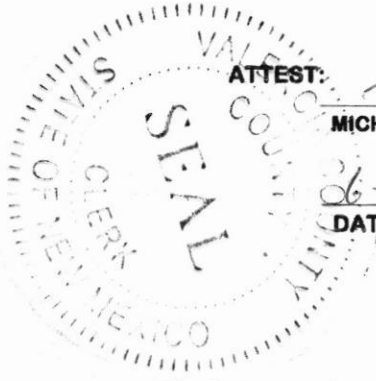
